## **ORDINANCE NO. 2022-07**

## AN ORDINANCE ESTABLISHING A NEW WELLINGTON CITY FEE SCHEDULE FOR WATER AND SEWER CONNECTION FEE.

WHEREAS, Wellington City operates and maintains water lines, hereinafter referred to as "City Services", within it's corporate limits for the benefit of its residents and non-residents; and

WHEREAS, Wellington City charges certain fees for services rendered for connections; and

WHEREAS, circumstances require that the fee for such services be increased to enable Wellington City to continue the operation of its water lines and to continue providing necessary services;

NOW, THEREFORE, BE IT HEREBY RESOLVED, by Wellington City Council as follows:

## Section I. Adoption of the Fee Schedule:

That the Fee Schedule, which is attached hereto, as "Exhibit A – Wellington City Water Service Connection Fee Schedule" be adopted.

## Section II. Repealer:

All provisions of other resolutions in conflict with this resolution are hereby repealed.

## Section III. Severability:

The provisions of this resolution and the provisions adopted or incorporated by reference are severable.

## Section IV: Effective Date:

In the opinion of the City council of Wellington City, it is necessary for the preservation of the peace, health and safety of the City and the inhabitants thereof that this resolution takes effect immediately after its approval and adoption

# EXIBIT A – WELLINGTON CITY WATER CONNECTION FEE SCHEDULE

## WELLINGTON CITY WATER AND SEWER CONNECTION FEE SCHEDULE

## **Security Deposit:**

Each new applicant for utility services shall pay a utility deposit fee in the amount of \$200 for a residence, \$300 for a commercial user and \$500 for an industrial user. Said fee shall serve as the security deposit for water, sewer, secondary irrigation, and garbage collection. Said deposit shall be paid prior to turning on of water services to the applicant premises and for new structures, this fee shall be paid at the time of issuance of the building permit.

## Sewer

The new connection fee shall be \$250.00

PRWID - Connection fee must be paid to PRWID. Customer must call them to connect and pay.

### **Culinary Water Service Connection Fee**

The service connection (hookup) fee shall be as follows:

- 1. \$800.00 for a ¾" connection
- 2. \$1,200.00 for a 1" connection
- 3. \$1,500.00 for a 1 1/2" connection with a new meter
- 4. \$2,000.00 for a 2" connection with a new meter

Special negotiations with City Council must be made for 3" or larger connections.

All connections must be made through Wellington City. No outside contractors will be allowed.
